

# RIGGING BUDGET REQUEST

#### INFORMATION REQUIRED TO MAKE A QUOTATION

- The location and orientation of the booth in the exhibition area.
- Indicate on the booth floor plan where the hanging points must be, including the distances (dimensions) from as reference 0.
- The maximum weight for every hanging point ordered.
- Assistance for set up and dismantling days and work schedule forecast.

#### INFORMATION FOR THE STAND BUILDER

- Any elevation system, structures or materials needed below the rigging points will be quoted separately, as well as the technicians needed for that purpose.
- From 1 to 4 points, the manual hoist chain is included.
- Requests from 5 rigging points for a single hanging element, it'll be mandatory to use an electric hoist for its elevation. This is not included in the price per point.
- All the rigging points set up by the CCIB get a certificate by an engineer included in the final price. It is calculated according to the information provided by the stand builder (number of points and weight).
- In the creation of the rigging points it's included the material, staff, machinery and official certificate.

### **RIGGING POINTS RANGE**

The rigging point range will be applied to one booth space:

From 1 to 4 points: 520 € / point. Includes the fixed point + manual hoist + safety. For a motorized elevation system, additional material and staff will be quoted.

From 5 to 8 points: 478 € / point. Includes the fixed rigging point. The motorized elevation system (electrical hoist + accessories) and 1 technician for set up and dismantling will be quoted separately. When ordering a truss structure, additional material and staff will be added.

From 9 to 12 points: 425 € / point. Includes the fixed rigging point. The motorized elevation system (electrical hoist + accessories) and 1 technician for set up and dismantling will be quoted separately. When ordering a truss structure, additional material and staff will be added.

From 13 rigging points or special requests, we'll prepare a personalized quote.






## REGULATION FOR THE STAND BUILDER


- Only the CCIB staff will be responsible for manipulating the materials provided and installed by the venue.
- The rigging point set up by the stand builder must meet the European regulations, the supplier certification or, at least, present an official certificate of structural strength.
- The use of nylon/plastic flanges is only allowed for fixing wires. For the other elements (lighting, pipes, etc) will be prohibited.
- It's absolutely forbidden screwing, drilling or piercing the materials and structures provided by the venue.
- It is not allowed to use polyester slings for hanging elements.


